

## **OFFICIAL RULES**

### **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The **#CHANDONxGLITTERGUIDE** Sweepstakes ("Sweepstakes") is only open to legal residents of the 50 United States and the District of Columbia, age 21 or older at time of entry. At the judges' discretion, the notified potential winner will be required to complete and return an Affidavit of Eligibility and Liability and a Publicity Release within 7 days from the date of prize notification or an alternate winner will be selected.
