

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The "2015 Veuve Clicquot Polo Classic" ("Sweepstakes") is only open to legal residents of and physically residing within Connecticut, New Jersey and New York, age 21 or older at time of entry.
