

## OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The "Veuve Clicquot Polo Classic and *New York Magazine*: Clicquot Picnic" Sweepstakes ("Sweepstakes") is only open to legal residents of the continental United States and District of Columbia, **age 21 or older** at time of entry. Employees of the *New York Magazine* ("Sponsor"), Veuve Clicquot, LVMH, Havas and its respective parent company/companies, subsidiaries, affiliates, retailers, advertising and promotion agencies and all other companies involved in this Sweepstakes and their immediate family members and/or those living in the same household of each are not eligible to enter or win. Odds of winning depend on number of eligible Entries received during the Sweepstakes Entry Period. Prizing is at the sole discretion of the Sponsor.

Potential winner will be selected in a random drawing from all eligible Entries received during the Sweepstakes Entry Period. Random drawing will be conducted within approximately 24 hours after the Sweepstakes end date by a representative from the Sponsor ("judges") whose decisions are final.

Potential winner will be notified on platform of entry via Direct Message to the entrant's account and he/she must respond via email within 24 hours from notification and provide his/her contact information or an alternate potential winner will be selected. At the judges' discretion, the notified potential winner(s) will be required to complete and return an Affidavit of Eligibility and Liability and a Publicity Release within 48 hours (2 days) from the date of prize notification or an alternate winner will be selected.
