

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ELIGIBILITY: The “Beautiful – The Carole King Musical & New York Weddings Event” Sweepstakes (“Sweepstakes”) is only open to legal residents of New York, New Jersey and Connecticut who are age 18 or older, as of time of Entry. Beautiful – The Carole King Musical, Serino/Coyne and its respective parent company/companies, subsidiaries, affiliates, retailers, advertising and promotion agencies and all other companies involved in this Sweepstakes and their immediate family members and/or those living in the same household of each are not eligible to enter or win. Note that available Beautiful The Musical show dates and times are at the sole discretion of Sponsor. The New York Weddings event will take place on Tuesday, March 28, 2017 from 5-8pm.

Random drawing will be conducted within 12 hours after the Sweepstakes end date on or about 3/24/17 by a representative from the Sponsor ("judges") whose decisions are final.
